The current Superintendent Wayne Walbridge is retiring June 30th, 2019 after many years of distinguished service for St. Regis Falls and other Northern New York Schools. The search process will be conducted over the next several months, with the new Superintendent taking office on July 1st, 2019.

CONTRACT AND SALARY INFORMATION

The Board of Education plans to offer a three-year contract with an initial salary in the \$115,000—\$130,000 range depending upon the successful candidate's preparation, qualifications, experience and reputation as an educational leader.

PROFILE OF THE NEW SUPERINTENDENT OF SCHOOLS

The St. Regis Falls Central School District Board of Education is seeking a committed, energetic leader for an enterprising, community-based school. The successful candidate must have strong human relations, educational, organizational and leadership skills. The Board of Education requires a candidate who must:

- Be a person of high moral character and unquestionable integrity who can instill credibility, confidence and pride in the school
- Hold or be eligible for New York State certification as a School District Administrator or School District Leader
- Have a vision for creating continuous growth for all students
- Be committed to upholding high professional standards and all school policies in a firm, fair and consistent manner
- Demonstrate successful administrative experience and a commitment to producing high quality educational programs that promote the development of engaged and successful students
- Demonstrate leadership implementing a rigorous and relevant education program utilizing the NYS Next Generation Standards as a foundation for local curriculum development.
- Be committed to keeping the Board of Education well informed; keeping the lines of communication open between the school, parents and community; and working together as a team
- Engage the community in educational program planning, budget planning and implementation of same
- Possess the ability to maintain positive discipline and to command the respect of students, staff and the community

THE SCHOOL AND COMMUNITY

The St. Regis Falls Central School provides a public education to approximately 267 students from the towns of Dickinson, Hopkinton, Lawrence, Santa Clara, and Waverly, which encompass an area of about 239 square miles.

The Board of Education is committed to maintaining a comprehensive educational program for all students, including those with special needs. The School District has a full range of educational, athletic, and co-curricular activities, which provide ample opportunities for students to explore and express their interests.

Students are housed in a single facility that provides for an effective educational program. The school, opened in September of 2001, features a 400-seat Auditorium, a Media Center, two Microcomputer Labs, and a spacious Gymnasium. The District began utilizing the new state-of-the art Distance Learning Classroom in 2006. The classroom was upgraded in 2013 with the latest generation of equipment. Currently there is a \$7.9 million restoration and expansion capital project underway that includes a large group instructional area and several mechanical and electrical upgrades.

The St. Regis Falls Central School District is a component member of the Franklin-Essex-Hamilton Board of Cooperative Educational Services. The District receives a variety of specialized shared services from the BOCES including career and technical education, educational programs for children with handicapping conditions, itinerant services, performing arts, computer applications, the shared business office, and other instructional support and management services.

DISTRICT AND FINANCIAL DATA

The St. Regis Falls Central School District contains taxable real property with a true value of \$161,461,027. The 2018-2019 tax rate per \$1,000 of true value is \$17.27.

The adopted 2018-2019 school budget is \$8,480,557. The tax levy was \$2,788,575, and the estimated state aid amount is \$5,177,199.
